## INTRODUCTION

1  
2 If there had previously been any question about whether the Select Commit-  
3 tee views its purpose primarily as an unconstitutional exercise of law enforcement  
4 powers that belong to the executive branch rather than a legitimate legislative func-  
5 tion, its opposition brief removes any doubt.<sup>1</sup> The Select Committee has used that  
6 brief, which was supposed to address privilege claims over 4 days of emails, as an  
7 opportunity to provide what is effectively a 60-page criminal indictment against  
8 the former President, bringing within its dragnet anyone who, like Dr. Eastman,  
9 provided legal advice or who otherwise fell within the former President's orbit. It  
10 is based on lies, distortions drawn from select snippets of behind-closed-door testi-  
11 mony, and innuendo.<sup>23</sup> *See* Statement of Disputed Facts. Yet the distortions cannot  
12 hide the fact that Dr. Eastman provided legal advice to a client in connection with  
13 numerous post-election legal challenges and a joint session of Congress from  
14 which litigation was certainly anticipated as a possibility, giving rise to attorney-  
15 client and work product protections of his communications.

## ARGUMENT

1           **I. Dr. Eastman’s Attorney-Client Relationship With Former President**  
2           **Trump and his Campaign Committee Is Well-Established.**

3           In their opposition, the defendants claim that “Plaintiff does not even at-  
4           tempt in his declaration to claim attorney-client privilege over the relevant matters  
5           and the relevant time at issue here.” Opp. at 20. That is not true. “Matters related to  
6           the Electoral College,” which would include the counting of the Electoral College  
7           votes on January 6, 2021, was expressly addressed in Eastman’s Declaration. 2d  
8           Eastman Decl. ¶ 24 (the representation was for “federal litigation matters in rela-  
9           tion to the 2020 presidential general election, *including matters related to the Elec-*  
10          *toral College.*” (emphasis added)).

11          The Select Committee also fixates on the fact that the engagement letter  
12          Eastman produced was “unsigned,” but that conflates the separate issues of the for-  
13          mation of an attorney-client relationship with the circumstances in which the attor-  
14          ney-client privilege applies. Further, Defendants misstate and misapply the law  
15          with respect to both.

16           **A. Formation of the Attorney-Client Relationship**

17          Under California law, a “client” is “a person who, directly or through an au-  
18          thorized representative, consults a lawyer for the purpose of retaining the lawyer or  
19          securing legal service or advice from him in his professional capacity....” Cal.  
20          Evid. Code § 951. In D.C., “A person who discusses with a lawyer the possibility  
21          of forming a client-lawyer relationship with respect to a matter is a prospective cli-  
22          ent.” DC R RPC Rule 1.18. In both cases, obligations of confidentiality are trig-  
23          gered. There is no requirement that such a relationship be formed in writing. *Lister*  
24          *v. State Bar*, 51 Cal.3d 1117, 1126 (1990); *In re Lieber*, 442 A.2d 153, 156 (D.C.  
25          1982) (observing that “[i]t is well established that neither a written agreement nor  
26          the payment of fees is necessary to create an attorney-client relationship”). All that  
27          is needed “is that the parties[,] explicitly or by their conduct, manifest an intention  
28

1 to create” the relationship. *In re Dickens*, 174 A.3d 283, 296 (D.C. 2017) (internal  
2 quotation marks omitted).

3 Further, while the formation of such a relationship is bi-lateral, courts defer  
4 to the client’s conduct in establishing the relationship’s existence. *See Responsible*  
5 *Citizens v. Superior Court (Askins)*, 16 Cal.App.4th 1717 (1993) (“one of the most  
6 important facts involved in finding an attorney-client relationship is the expecta-  
7 tion of the client based on how the situation appears to a reasonable person in the  
8 client’s position.” [internal quotes and citation omitted]). President Trump cer-  
9 tainly considered Dr. Eastman to be his lawyer in the “relevant time period” and  
10 for the “relevant matters” at issue here. As the Select Committee has already  
11 acknowledged, Trump asked Dr. Eastman to an oval office meeting on January 4,  
12 2021, to give advice on the constitutional authority of the Vice President while pre-  
13 siding over the joint session of Congress on January 6, 2021. Opp. at 10. Indeed,  
14 on January 5, 2021—smack dab in the middle of the time period at issue here—Dr.  
15 Eastman appeared in Court on behalf of the President, *Trump v. Kemp*, No. 1:20-  
16 cv-05310 (N.D. Ga., filed Dec. 31, 2020). Dr. Eastman’s appearance in that case is  
17 a matter of public record. *See* Dkt.#17 (application for *pro hac vice* admission, ap-  
18 proved Jan. 6, 2021).<sup>4</sup> Moreover, courts have consistently held that attorneys who  
19 file on behalf of a party represent to the court that an attorney-client relationship  
20 exists. *See, e.g., In re Fay*, 111 A.3d 1025, 1030 (D.C. 2015) (stating that they “un-  
21 dertake the ethical duties stemming from an attorney-client relationship by making  
22 an appearance on behalf of the retained attorney’s client”).

### 23 **B. Applicability of the Attorney-Client Privilege**

24 Even if this Court were to find that a formal attorney-client contractual rela-  
25 tionship had not been formed, the law is plain that the attorney-client privilege is  
26 an ethical responsibility owed by attorneys to clients *and prospective clients*, irre-  
27 spective of their contractual arrangement. *In re Ryan*, 670 A.2d 375, 380 (D.C.

1 1996). Such “ethical responsibilities exist independently of contractual rights and  
2 duties,” and arise from the “establishment of a fiduciary relationship” that “is often  
3 established before a contract even exists.” *Id.* at 379-80. “All that is required...is  
4 that the parties, explicitly or by their conduct, manifest an intention to create the at-  
5 torney/client relationship.” *Id.* (quoting *Nolan v. Foreman*, 665 F.2d 738, 739 n. 3  
6 (5th Cir.1982)). The Select Committee’s assertion that the non-existence of a con-  
7 tractual relationship means the privilege cannot apply is therefore incorrect.

8 Drawing from the ABA Code of Professional Responsibility, the Seventh  
9 Circuit identified five “fairly common” situations in which an implied professional  
10 ethical obligation exists, despite no express formation of an attorney-client rela-  
11 tionship. *Westinghouse Elec. Corp. v. Kerr-McGee Corp.*, 580 F.2d 1311, 1319  
12 (7th Cir. 1978). Most directly on point is the duty owed to a client arising in “pre-  
13 liminary consultation by a prospective client with a view to retention of the lawyer,  
14 although actual employment does not result.” *Id.* See also, *Taylor v. Sheldon*, 172  
15 Ohio St. 118, 173 N.E.2d 892, 895 (1961) (“Communications in the course of pre-  
16 liminary discussion with a view to employing the lawyer are privileged though the  
17 employment is in the upshot not accepted.”).

18 Election integrity is clearly a legal matter, and it was clearly a matter on  
19 which the former President was seeking legal advice. When Cleta Mitchell con-  
20 tacted Dr. Eastman on September 3, 2020, the communication was made to Dr.  
21 Eastman under the apparent authority of the President by one of his attorneys,  
22 whose client had authorized her to consult with other attorneys for the purpose of  
23 procuring legal advice regarding election integrity. 2d Eastman Decl. ¶ 25. That re-  
24 lationship continued through Dr. Eastman’s “legal consultation” meeting in Phila-  
25 delphia on November 7, *id.* ¶ 27; his appearances before the Supreme Court on be-  
26 half of President Trump on December 9 and 21, *id.* ¶ 20; his appearance in the  
27 Northern District of Georgia on December 31, *id.*; and his oval office meeting and  
28 further discussions on January 4, 2021, and beyond.

1           **II. No Waiver by Use of Chapman Email.**

2           The Select Committee’s claim that Dr. Eastman’s use of Chapman’s email  
3 system was not authorized overstates the prior statements made by Chapman and  
4 ignores entirely that Dr. Eastman disputes even those post-hoc statements.

5           For example, the Committee does not address at all the assertions in Dr.  
6 Eastman’s sworn declaration that his employment expressly authorized outside em-  
7 ployment “separate and apart from [his] employment as a Faculty Member,” that  
8 academically-oriented court briefs were considered as scholarship for promotion  
9 and tenure decisions at Chapman, and that American Bar Association Standard  
10 402(c), which was incorporated by reference in the Chapman Law Faculty Hand-  
11 book, specifically permits “outside professional activities” that “relate to major ac-  
12 ademic interests or enrich the faculty member’s capacity as scholar and teacher  
13 [and] are of service to the legal profession and the public generally.” 2d Eastman  
14 Decl. ¶¶ 3, 8, 9. Dr. Eastman cited three prior examples of such “outside” work us-  
15 ing Chapman’s email and other resources that involved post-election or other elec-  
16 tion-related litigation, for which Chapman praised his efforts. That in this instance  
17 Chapman, after the fact, decided to distance itself from that work because, well,  
18 Trump is apparently different, does not alter the fact that the prior precedent gave  
19 Eastman more than enough ground to subjectively and reasonably belief that this  
20 work was also permissible.

21           Nor does the University President’s post-hoc “admonishment,” as the Com-  
22 mittee calls it, alter that conclusion. The statement notes that Struppa had directed  
23 Eastman “to remove from his private filing any direct or indirect reference to  
24 Chapman University and formally file such change with the court.” Eastman did  
25 that the very next day. Struppa further notes that Eastman’s freedom to represent  
26 whomever he chooses “should not be construed as implying any concurrence or  
27 approval for his actions by the University”—an implication that until that time had,  
28 as a matter of common practice and explicit guidance, been rebutted by the use of

1 “c/o” before the Chapman University name and address. Struppa further noted that,  
2 “as a nonprofit institution, Chapman University does not participate in, endorse or  
3 intervene in any political campaign on behalf of or in opposition to any candidate.”  
4 But as we have previously noted, post-election litigation does not run afoul of that  
5 non-profit requirement.<sup>5</sup>

6 Nor is it true that, had the constitutional jurisprudence clinic which Eastman  
7 co-directed (and continued to co-direct, for a stipend, even while he was otherwise  
8 on leave) not been between semesters, his post-election litigation work would not  
9 have been a clinic project for interested students, just as his post-2000 election ef-  
10 forts had involved Chapman students. The assertion by Chapman’s counsel to the  
11 contrary is not based on anything in DuMontelle’s Declaration, prior practice, or  
12 on any requirement that the constitutional jurisprudence clinic (or any of the other  
13 law school clinics) obtain advance approval for particular matters they undertake.

14 As importantly, the case law upon which the Select Committee rests dealt  
15 with attorney-client privilege, not work product, where the standard for waiver is  
16 much less, as even the Committee concedes. So even if Dr. Eastman’s use of Chap-  
17 man’s email system amounted to a disclosure to third parties, only the attorney-cli-  
18 ent privilege rather than the work product would be impacted. And even there, for  
19 the reasons set out above, such disclosure would not have been with the implied  
20 consent of the client necessary to effect a waiver. *See Tillotson v. Boughner*, 350  
21 F.2d 663, 665 (7th Cir. 1965) (“the privilege is that of the client”); *Perrignon v.*  
22 *Bergen Brunswig Corp.*, 77 F.R.D. 455, 459 (N.D. Cal. 1978) (“Before there can  
23

25 <sup>5</sup> Nor does the “splash” message about emails being subject to monitoring, or  
26 Chapman’s policy about privacy, alter this expectation. Eastman’s laptop use did  
27 not trigger the “splash” message, and the privacy policy necessarily had to have an  
28 implied exception for legal clinic work and “outside work” that included legal  
briefs in furtherance of scholarly and public service duties, lest the policy place all  
Chapman clinical professors in violation of their ethical obligations of confidenti-  
ality.

1 be a waiver, therefore, [the client] through its counsel must have voluntarily con-  
2 sented to [the] disclosure”).

3 In sum, Eastman’s employment agreement, the law faculty rank and tenure  
4 procedures and faculty manual, and prior practice all gave Eastman a subjective  
5 and reasonable belief that his work on this matter was not only authorized but that  
6 his email exchanges using his official bar-reflected Chapman email address did not  
7 constitute a waiver of any applicable privileges.

### 8 **III. Defendants’ Other Claims of Waiver Are Unavailing.**

#### 9 **A. Trump’s “Authorization” Was Not A Waiver**

10 The Select Committee’s assertion that the Attorney-Client privilege has been  
11 waived because Dr. Eastman’s client authorized him to “talk about these things”  
12 and had given him “express authorization” “to describe what occurred” is based, as  
13 seems to be the Select Committee’s modus operandi, on statements taken wholly  
14 out of context. The first—the “talk about these things” statement made during a  
15 podcast with Harvard Law Professor Lawrence Lessig—quite explicitly referenced  
16 the constitutional authority of the Vice President under Article II and the 12<sup>th</sup>  
17 Amendment that was discussed in the scenarios memos, not election litigation or  
18 electoral college disputes more broadly. And the “express authorization ... to de-  
19 scribe what occurred” that was articulated by Dr. Eastman during his interview on  
20 the Peter Boyles Show was quite explicitly about the meeting that Dr. Eastman had  
21 with President Trump, Vice President Pence, and two of Pence’s aids in the oval  
22 office on January 4, 2021. Eastman noted it was a “private conversation,” but  
23 never claimed it was a “privileged conversation.” Indeed, the presence of people  
24 outside the attorney-client relationship made it a non-privileged conversation from  
25 the outset. *See* Opp. at 22 (citing *Sony Computer Ent. Am., Inc. v. Great Am. Ins.*  
26 *Co.*, 229 F.R.D. 632, 634 (N.D. Cal. 2005) (“Where a third party is present, no pre-  
27 sumption of confidentiality obtains”). The Select Committee’s argument to the  
28 contrary completely overlooks that dispositive point.

1 Dr. Eastman has also not asserted attorney-client privilege over his memos  
2 outlining different scenarios for the January 6 joint session of Congress, so their  
3 disclosure cannot waive a privilege that did not exist. *Champion Int’l Corp. v. Int’l*  
4 *Paper Co.*, 486 F. Supp. 1328, 1330 n.2 (N.D. Ga. 1980) (disclosure of “nonprivi-  
5 leged documents” “does not waive the privileged communications ... on the same  
6 subject”). Moreover, even if the release of Dr. Eastman’s scenarios memos consti-  
7 tuted a waiver of some privilege (more likely work product rather than attorney-  
8 client), Dr. Eastman has asserted attorney-client privilege only over 5 emails (four  
9 of which had an attachment) in the batch of production at issue here. As will be ev-  
10 ident from the Court’s *in camera* review, three of those emails (Chapman004722,  
11 Chapman004744, and Chapman004766) and their attachments (Chapman004723,  
12 Chapman004745, and Chapman004767) are duplicates, and a fourth email (Chap-  
13 man004788) is identical except that it has a google docs link to the attachment ra-  
14 ther than the attachment itself. Those four emails contain a discussion with co-  
15 counsel about advice to be given to Dr. Eastman’s client that is on different matters  
16 than are addressed in the scenarios memos themselves, and is therefore not the  
17 “same subject” as the disclosed memos. And the fifth email (together with its at-  
18 tachment) addressed statutory and constitutional deadlines, not the process of the  
19 joint session of Congress addressed in the scenarios memos. It is therefore also not  
20 about the “same subject” as the memos.

21 **B. Disclosure to an “Agent” Is Not Waiver**

22 The law is beyond dispute that the attorney-client privilege attaches to com-  
23 munications between an attorney and the client’s agent and between an attorney’s  
24 agent and the client. *United States v. Christensen*, 828 F.3d 763, 802-03 (9th Cir.  
25 2015); *In re Kellogg Brown & Root, Inc.*, 756 F.3d 754, 757 (D.C. Cir. 2014); Paul  
26 R. Rice, *Attorney-Client Privilege in the United States* § 3:3 (2014)); 8 Wigmore,  
27 *Evidence* § 2301 (McNaughten Rev. 1961). Agency law, since it permits someone  
28 to act as an agent on behalf of someone else even under color of authority,

1 combined with the attorney-client privilege, makes it evident that communications  
2 between an agent acting on behalf of either the client or the attorney with either the  
3 attorney or the client, whether directly or again, through agents, is given the same  
4 protections as those given when made directly, without an agent. This is because, if  
5 the communications are related to the representation and for the purpose of repre-  
6 senting the client on a confidential matter, as is abundantly clear here, the purpose  
7 and intent of the law is to give that the highest protection to ensure adequate repre-  
8 sentation without the concern of those communications later being divulged to  
9 third parties.

10 The two people included on the only documents at issue here for which At-  
11 torney-Client privilege is claimed were attorneys working with the Trump legal  
12 team, and as such were “agents” of the client. *See Ins. Co. of N. Am. v. Super. Ct.*,  
13 108 Cal. App. 3d 758, 771 (1980) (holding that attorney-client communications in  
14 the presence of an unpaid legal consultant remained privileged because the consult-  
15 ant was present to further the interest of the client).

16 **IV. The Work Product Protection Is Neither Waived Nor Overcome By**  
17 **“Substantial Need.”**

18 **A. The Work Product Protection has Not Been Waived Through Disclo-**  
19 **sure to an Adversary or by Any Other Means.**

20 The defendants first argue that the *in camera* materials are not prepared “in  
21 anticipation of litigation.” Opp. at 31-32. However, the law is clear that memo-  
22 randa noting likely legal challenges and potential defenses are unquestionably pro-  
23 tected by the work product privilege. *See Delaney, Migdail & Young, Chartered v.*  
24 *IRS*, 826 F.2d 124, 127 (D.C. Cir. 1987) (cited with approval in *Am. C.L. Union of*  
25 *N. California v. United States Dep’t of Just.*, 880 F.3d 473, 486-87 (9th Cir.  
26 2018)); *In re Grand Jury Subpoena (Mark Torf/Torf Environmental*, 357 F.3d 900,  
27 907 (9th Cir. 2004) (opinions prepared by expert to assess client’s civil and  
28

1 criminal liability are unquestionably protected).<sup>6</sup> Although plaintiff cannot discuss  
2 the details of the *in camera* materials without waiving the privilege, plaintiff sub-  
3 mits their connection to anticipated litigation will be manifest during this Court’s  
4 review. Many of the documents relate specifically to pending court cases. Those  
5 that relate to the electoral college were also prepared with potential litigation in  
6 mind. “Forcing an attorney to disclose [documents] ... that reveal the attorney’s  
7 mental processes” is “particularly disfavored.” *Upjohn v. United States*, 449 U.S.  
8 383, 399 (1981). This strong public policy in protecting an attorney’s mental pro-  
9 cesses is the basis for the work product privilege, and the privilege applies to gov-  
10 ernment investigations beyond the confines of regular litigation. *See id.* at 397-98.  
11 Although the proceedings of the electoral college themselves may not constitute  
12 litigation, legal representation with respect to the electoral college must obviously  
13 be undertaken with potential court challenges clearly in mind.<sup>7</sup>

14 The defendants then argue that the plaintiff’s work product claim is “vi-  
15 tiat[ed]” due to unethical conduct by plaintiff. *Opp.* at 32. The defendants make the  
16 conclusory statement that Plaintiff’s advice was aimed at “overturning a demo-  
17 cratic election.” *Id.* However, even a cursory view of the *in camera* materials will  
18 reveal a genuine motivation on behalf of plaintiff and others to protect the demo-  
19 cratic process. The fact that the defendants may disagree with the factual predicates  
20 of that effort does not render the conduct unethical.<sup>8</sup> Defendants offer no evidence

1 sufficient for this Court to conclude as a matter of law that no material fraud or il-  
2 legality existed in the 2020 election, let alone that Plaintiff should be imputed with  
3 knowledge of that fact in the January 4-7 time period. In fact, the 2020 election re-  
4 mains a hotly contested subject of debate to this day. *See Statement of Disputed*  
5 *Facts*. The Wisconsin Special Counsel has recently issued a report finding illegal  
6 and fraudulent voting practices that affected the outcome of the Presidential Elec-  
7 tion in that state. *See, e.g.,* Wisconsin Office of the Special Counsel, *Second In-*  
8 *terim Investigative Report on the Apparatus & Procedures of the Wisconsin Elec-*  
9 *tions System*, at 7-8 (March 1, 2022) (identifying numerous violations of election  
10 laws and outright fraud).<sup>9</sup> This Court would need a full-scale trial, complete with  
11 expert audits of the contested state election tallies before it could even consider  
12 Defendants’ arguments for breaching the work product privilege.

13 Next, Defendants argue that Plaintiff’s work product claims are defeated be-  
14 cause he disclosed the materials to nonlawyers and persons with whom he did not  
15 share an “agent” relationship. Opp.33. Defendants cite no authority which limits  
16 sharing of work product to lawyers or agents because the work product doctrine  
17 contains no such limitation. *Hickman v. Taylor*, 329 U.S. 495, 498, 510-11 (1947)  
18 (work product privilege protects an attorney’s opinions and strategies.).

19 In fact, as the defendants acknowledge, work product privilege is only  
20 waived by voluntarily sharing the protected information with an adversary. *United*  
21 *States v. Sanmina Corp.*, 968 F.3d 1107, 1120 (9th Cir. 2020). This is not only the  
22 rule in the Ninth Circuit, but also the rule of the “overwhelming majority” of cir-  
23 cuits that have considered the question. *Id.* Further, the work product privilege sur-  
24 vives the termination of the litigation (or the plans for litigation) for which the  
25 product was created. *See FTC v. Grolier, Inc.*, 462 U.S. 19, 25 (1983).<sup>10</sup>

1 Next, the defendants offer a five-word quote from *Sanmia* which they claim  
2 requires disclosure because “fairness requires it.” Opp.35 (*citing Sanmina*, 968  
3 F.3d at 1122). However, the full quote from *Sanmina* shows very clearly that the  
4 case dealt only with disclosure to adversaries and did not announce an all encom-  
5 passing “fairness” standard. The full quote from which defendants have excerpted  
6 a single phrase is as follows: “we may find the work-product immunity waived  
7 *where the disclosing parties conduct has reached a certain point of disclosure to-*  
8 *wards his adversary* such that fairness requires that his privilege shall cease,  
9 whether he intended that result or not.” *Id* (internal quotation omitted and italics  
10 added). Thus, the defendants “fairness” argument rests on a misleading partial quo-  
11 tation of *Sanmina*.<sup>11</sup>

12 **B. The Defendants Have Not Shown Any Substantial Need that Would**  
13 **Overcome Work Product Protection.**

14 The Federal Rules allow for the discovery of work product where “the party  
15 shows it has substantial need for the materials *to prepare its case.*” Fed. R. Civ.  
16 Proc. 26(b)(3)(A)(ii) (italics added). The Select Committee is not seeking the  
17 Chapman materials to “prepare its case” but rather for the completely ancillary  
18 purpose of conducting a congressional investigation. The cases relied on by de-  
19 fendants all involve parties seeking discovery of materials for use in pending litiga-  
20 tion rather than some ancillary purpose. *See, e.g., Admiral Ins. Co. v. U.S. Dist.*  
21 *Court for Dist. Of Arizona*, 881 F.2d 1486, 1495 (9th Cir. 1989) (considering rule

22

1 in the context of “information plaintiffs need to establish their claims”); *Fletcher v.*  
2 *Union Pacific R.R. Co.*, 194 F.R.D. 666 (S.D. Cal. 2000) (plaintiff seeking work  
3 product materials in support of employment claim). Plaintiffs have offered no sub-  
4 stantial need for the *in camera* materials for purposes of litigation before this or  
5 any other court. Their claim therefore does not even implicate Rule 26’s “substan-  
6 tial need” provision.

7 Even if Rule 26 could somehow be stretched to cover a party’s “substantial  
8 need” for purposes unrelated to the litigation (or *any* litigation), the defendants  
9 have made no such showing. Because of the strong public policy protecting an at-  
10 torney’s opinions, something “far stronger” than a normal showing of necessity  
11 and unavailability is required to compel disclosure. *Upjohn*, 449 U.S. at 401-02.  
12 The Fourth Circuit has ruled that “no showing of relevance, substantial need or un-  
13 due hardship should justify compelled disclosure of an attorney’s mental impres-  
14 sions, conclusions, opinions or legal theories.” *Duplan Corp. v. Moulinage et Re-*  
15 *torderie de Chavnaoz*, 509 F.2d 730, 734 (4th Cir. 1974). The Ninth Circuit has  
16 limited discovery of opinion work product to situations where “mental impressions  
17 are at issue in a case and the need for the material is compelling.” *Holmgren v.*  
18 *State Farm Mut. Auto. Inc. Co.*, 976 F.2d 573, 577 (9th Cir.1992).

19 *U.S. v. McGraw-Hill Companies, Inc.*, 2014 WL 8662657 (C.D. Cal.), and  
20 *Reavis v. Metro. Prop. & Liab. Ins. Co.*, 117 F.R.D. 160, 164 (S.D. Cal. 1987), re-  
21 lied on by Defendants, Opp. at 36, are beside the point. Both involved work prod-  
22 uct that was “pertinent to the party’s ‘most salient defense’” and the attorney’s  
23 mental impressions were “directly at issue in the case.” *McGraw-Hill*, at \*6-7;  
24 *Reavis*, 117 F.R.D. at 164. Moreover, even if ancillary investigations such as the  
25 Select Committee’s could be considered “a case,” Dr. Eastman’s “mental impres-  
26 sions” are at most relevant for law enforcement purposes in which the Committee  
27 has no constitutional role, not any legislative purpose. Defendants have therefore  
28

1 not established a valid compelling need for disclosure of the work product privi-  
2 leged documents at issue.

3 **V. The Committee’s Crime-Fraud Claims Are Without Merit.**

4 The Select Committee asserts that Dr. Eastman’s email exchange with Greg  
5 Jacob, Counsel to Vice President Pence, “urg[ed] the Vice President to take illegal  
6 action and refuse to count electoral votes.” That statement is misleading on two  
7 grounds. First, the email exchange on which it is based makes quite clear that Dr.  
8 Eastman had urged a delay, not a “refus[al] to count electoral votes.” Second, the  
9 email exchange also makes clear that the Electoral Count Act’s timing provisions  
10 had already been violated by Vice President Pence, the House of Representatives,  
11 and the Senate by allowing for extended debate past the statutory limit even after  
12 the session had reconvened after the Capitol had been cleared. Such technical vio-  
13 lations of the Act were consistent with Dr. Eastman’s own well-grounded legal  
14 opinion (shared by other scholars) that the Electoral Count Act was unconstitu-  
15 tional to the extent it infringed on authority given to the Vice President directly  
16 from the Constitution. Urging that one exercise constitutional authority without im-  
17 pediment from an unconstitutional statute is not urging of “illegal action,” but ra-  
18 ther a recognition at least as old as *Marbury v. Madison* that the Constitution is su-  
19 perior to a mere statute.

20 The Select Committee’s other assertions of “crime” are equally meritless.

21 **A. There is No Good Faith Basis to Conclude that President Trump**  
22 **Used Plaintiff’s Legal Advice to Obstruct an Official Proceeding**

23 The Committee alleges that former President Trump used Plaintiff’s legal  
24 advice in connection with an attempt to obstruct justice under 18 U.S.C. § 1512.  
25 This allegation has multiple flaws.

26 First, the fact that the Select Committee may disagree with Plaintiff’s legal  
27 advice does not convert his representation of former President Trump into a crimi-  
28 nal matter. Plaintiff disputes the characterization of his legal advice contained in

1 the deposition excerpts from Mr. Jacob, but even if Mr. Jacob’s characterizations  
2 are assumed *arguendo*, they do not create a criminal issue when the advice was  
3 grounded on a good faith interpretation of the Constitution. (In contrast, the effort  
4 undertaken by Harvard Law Professors Tribe and Lessig in 2016 to encourage  
5 Trump electors to not vote for Trump was more problematic, to the extent the ef-  
6 fort encouraged conduct that would have been contrary to state laws against faith-  
7 less electors that exist in 33 states—one of which was upheld by the Supreme  
8 Court in *Chiafalo v. Washington*, 140 S. Ct. 2316 (2020). *See* Kyle Cheney, *Les-*  
9 *sig: 20 Trump electors could flip*, Politico (Dec. 13, 2016) (describing efforts by  
10 Lessig’s “anti-Trump group, ‘Electors Trust,’” to provide pro bono legal counsel to  
11 Trump electors “considering ditching Trump”); Jamie D. Halper, *Law School Pro-*  
12 *fessor Says 20 Republican Electors May Vote Against Trump*, The Harvard Crim-  
13 *son* (Dec. 18, 2016) (describing Lessig’s effort but also a letter co-signed by Har-  
14 vard Law Professor Lawrence Tribe encouraging electors not to vote for Trump);<sup>12</sup>  
15 Daniel Brezenoff, *et al.* (including Professor Tribe), Letter to Electors (Dec. 14,  
16 2016) (encouraging electors to vote against President-elect Trump because “ex-  
17 traordinary circumstances call for extraordinary measures”).<sup>13</sup>

18 Secondly, the defendants have not made a case that any of President  
19 Trump’s actions were done with criminal intent. “[A] defendant who ... lawfully  
20 lobbies Congress ahead of an official proceeding, or engages in First Amendment-  
21 protected protest activity does not act ‘corruptly’ within the meaning of the stat-  
22 ute.” *United States v. Sandlin*, 2021 WL 5865006, at \*12 (D.D.C. Dec. 10, 2021)  
23 (internal citations and footnotes omitted). As the defendants admit, the Ninth Cir-  
24 cuit has upheld a jury instruction requiring proof of “consciousness of wrongdo-  
25 ing” to obtain a 1512(c) conviction. *Opp.* at 40 (quoting *United States v. Lonich*,  
26 23 F.4th 881, 906 (9th Cir. 2022)). The Defendants’ own brief admits that

1 President Trump was presented with conflicting advice on whether the 2020 elec-  
2 tion was tainted by material fraud or illegality. As Plaintiff has previously noted,  
3 the defendants themselves offer testimony from former Acting Attorney General  
4 Jeffrey Rosen acknowledging this fact. ECF#172 at 4. Moreover, in their response  
5 to Plaintiff’s request for exculpatory evidence, the defendants do not deny that the  
6 President received advice and information that material fraud and illegality had in  
7 fact occurred in the 2020 election. ECF#178. The defendants have refused to pro-  
8 duce evidence in their possession of this conflicting advice, but the point was  
9 acknowledged by former Attorney General Will Barr as recently as this past week-  
10 end. *See* NBC Nightly News with Lester Holt (Barr: “one of the things is the Presi-  
11 dent was surrounded by these people who would very convincingly make the case  
12 for fraud”).

13 The Select Committee has presumably concluded that those who advised the  
14 President that no material fraud or illegality existed were correct and that those  
15 who offered the opposite advice were incorrect. The fact that former President  
16 Trump reached a different conclusion does not show “consciousness of wrongdo-  
17 ing.” It merely shows that the President arrived at a view of various factual ques-  
18 tions which the Select Committee does not share. The defendants have therefore  
19 failed to show that there is any good faith basis to conclude that President Trump  
20 or others acted with criminal intent.

21 **B. Conspiracy to Defraud the United States**

22 The defendants also argue that this Court should review the *in camera* mate-  
23 rials to determine if a good faith basis exists to conclude that President Trump used  
24 Plaintiff’s advice in furtherance of the criminal offense of Conspiracy to Defraud  
25 the United States under 18 U.S.C. § 371. There is no basis for such a conclusion.

26 Conspiracy to defraud the United States means obstructing any government  
27 agency by any “deceit, craft or trickery, or at least by means that are dishonest.”  
28 *United States v. Caldwell*, 989 F.2d 1056, 1058 (9th Cir. 1993). As with the

1 Obstruction of an Official Proceeding allegation analyzed above, the defendants’  
2 theory relies on the fact that certain individuals advised the President they did not  
3 believe material fraud or illegality had occurred in the 2020 election. However, as  
4 also set forth above, the defendants are admittedly hiding evidence of multiple  
5 Presidential advisers who contended that there had been significant material fraud  
6 and/or illegality. It is not “deceit, craft or trickery” for the President, based on  
7 counsel from trusted advisors, to have arrived at conclusions on various factual  
8 matters which the Select Committee does not share.

9 Even if the defendants could show that the President had criminal intent,  
10 there is no basis to conclude that the conspiracy “extended to the rioters engaged in  
11 acts of violence at the Capitol.” Opp. at 44. The defendants rely for this argument  
12 on a finding from a civil case against the President wherein the defendants claim  
13 the court found that “it was plausible to believe that the President entered into a  
14 conspiracy with the rioters.” *Id.* (citing *Thompson v. Trump*, 2022 WL 503385  
15 (D.D.C. Feb. 18 2022)). The defendants neglect to mention that the opinion arose  
16 from a motion to dismiss, which required the court to view the “facts in the light  
17 most favorable to Plaintiffs, and drawing all reasonable inferences in their favor.”  
18 *Id.* at 33. Judge Mehta’s finding is simply that, viewed in the most favorable light,  
19 the plaintiffs had adequately alleged a conspiracy between the President and cer-  
20 tain rioters. It is misleading in the extreme for the defendants to offer this case to  
21 the Court as actual evidence of a criminal conspiracy.

### 22 **C. Common Law Fraud**

23 Finally, the defendants allege this Court has a good faith basis to review the  
24 *in camera* materials for common law fraud. As the defendants admit, common law  
25 fraud requires a knowingly false misrepresentation. Opp. at 46-47 (citing *Atraqchi*  
26 *v. GMUC Unified Billing Servs.*, 788 A.2d 559, 563 (D.C. 2002)). Thus, the same  
27  
28

1 arguments about culpable intent set forth above with respect to the criminal of-  
2 fenses alleged by defendants also apply to common law fraud.<sup>14</sup>

### 3 **VI. Constitutional Claims**

7 <sup>14</sup> In support of their common law fraud allegation, the defendants offer the “spe-  
8 cific example” of a video of ballot counting in Georgia to “illustrate the point.”  
9 The defendants argue that the former President relied on this video to support a  
10 challenge to the Georgia election results despite being advised by the Georgia Sec-  
retary of State that it did not show fraud. As the defendants argue:

11 During this call, [Georgia Secretary of State] Raffensperger explained to the  
12 President that the video in question had been selectively edited, and that  
13 Raffensperger’s office had reviewed the full tape and found no evidence of  
14 fraud. Raffensperger also offered to provide the President a link to the full  
video, to which the President responded: “I don’t care about the link. I don’t  
need it.”

15 Opp. at 49. However, a brief review of the full transcript reveals it is the defend-  
16 ant’s representation of that conversation which is itself “selectively edited.” Ac-  
17 cording to a Washington Post transcription of the phone call, the relevant portion  
of the conversation was as follows:

18 **Raffensperger:** Mr. President, we’ll send you the link from WSB.

19 **Trump:** I don’t care about the link. I don’t need it. Brad, I have much better  
–

20 **Mitchell:** I will tell you. I’ve seen the tape. The full tape. So has Alex.  
21 We’ve watched it. And what we saw and what we’ve confirmed in the tim-  
22 ing is that they made everybody leave – we have sworn affidavits saying  
23 that. And then they began to process ballots. And our estimate is that there  
were roughly 18,000 ballots. We don’t know that. If you know that --.

24 As this exchange shows, the congressional defendants have selectively edited a  
25 portion of the phone call which supports their view, and omitted highly relevant  
26 context which cuts against it. The full exchange shows that President Trump was  
27 not dismissive of the full video, as defendants misleadingly suggest, but rather that  
28 Trump advisor Cleta Mitchell had watched the full video and concluded that there  
was in fact cause for concern. The defendants’ easily exposed misleading presenta-  
tion of this phone call should give the Court great skepticism about what other rel-  
evant evidence the Select Committee is withholding.

1 In response to Plaintiff’s First and Fourth Amendment arguments, the con-  
2 gressional defendants raise procedural objections while largely sidestepping the  
3 important constitutional questions presented.

4 Procedurally, the Defendants argue that Plaintiff’s constitutional claims are  
5 barred by Local Rule 7-18, because the Court has already considered them at the  
6 TRO stage. Opp.52. However, Plaintiff is not currently asking this Court to enter a  
7 TRO, so the rule does not apply.

8 Even if Rule 7-18 did apply, it allows for reconsideration on the grounds of  
9 “a material difference of fact” which could not have been known by reasonable dil-  
10 igence at the time of the prior ruling. Such is the case here. With the respect to the  
11 Fourth Amendment claim, plaintiff was not aware at the TRO stage of the search  
12 terms communicated to Chapman by the defendants which largely superseded the  
13 terms of the subpoena itself.

14 The First Amendment claim also involves material facts unknown at the  
15 TRO stage. Although ignored by defendants, Plaintiff explicitly based his First  
16 Amendment argument on *in camera* productions made subsequent to the TRO or-  
17 der. ECF 144 at 35-36. At the TRO stage the First Amendment question was  
18 largely abstract, but the thousands of pages of email productions have now made it  
19 concrete. It is appropriate to reconsider the First Amendment claim in light of these  
20 productions.

21 While raising various procedural defenses to Plaintiff’s First and Fourth  
22 Amendment claims, defendants offer no responses to the serious constitutional  
23 questions raised in Plaintiff’s brief. As to the First Amendment, Plaintiff specifi-  
24 cally posed the question of what limiting principle could apply to the Select Com-  
25 mittee’s claimed authority to investigate any “influencing factor” of January 6.  
26 ECF 132 at 35 (*citing Watkins v. United States*, 354 U.S. 178 (1957)). The defend-  
27 ants offer no answer to this question. Although Plaintiff is prohibited from divulg-  
28 ing the details of *in camera* productions in a public filing, the First Amendment



1 implications of the vast investigative power claimed by the Select Committee are  
2 manifest. One need only imagine an idealistic young person inspired to volunteer  
3 in the 2022 federal elections. There is no reason why some controversial aspect of  
4 this election might not also be the subject of investigation of an as-yet-to-be-con-  
5 stituted congressional committee. Would such person be chilled in exercise the ex-  
6 ercise of their speech rights by disclosure of the *in camera* materials?

7 Similarly, with respect to Plaintiff’s Fourth Amendment claim, defendants  
8 do not address the implications of the search term procedure imposed by them  
9 upon Chapman university. They do not dispute that the committee’s search terms  
10 effectively superseded the terms of the original subpoena and, in doing so, severed  
11 any necessary connection between the responsive documents and the 2020 elec-  
12 tion. For example, under the search term procedure, the Committee is effectively  
13 claiming a right to seize Plaintiff’s email communications on (for example)  
14 “China” or “Ted Cruz”, *even if such communications were completely unrelated to*  
15 *January 6 or the presidential election*. Again, it bears emphasis that the defendants  
16 have not disputed this necessary consequence of disregarding the subpoena lan-  
17 guage in favor of a collection of political search terms. Even putting aside subse-  
18 quent developments in Fourth Amendment law and relying purely on the decisions  
19 in *McPhaul v. United States*, 364 U.S. 372, 382 (1960), and *Oklahoma Press Pub.*  
20 *Co. v. Walling*, 327 U.S. 186, 209 (1946) (upon which defendants rely), the com-  
21 mittee’s search term procedure resulted in a subpoena that exceeded the scope of  
22 its legitimate inquiry.

### 23 CONCLUSION

24 For the foregoing reasons, plaintiff requests this Court order that the materi-  
25 als identified on plaintiff’s privilege logs are protected from disclosure to the de-  
26 fendants by the attorney client and work product privileges, and that the subpoena,  
27 particularly as implemented by the Committee’s search terms, violates the First  
28 and Fourth Amendments.
