### The "eyes and voice" of the people


"It is the proper duty of a representative body to look diligently into every affair of government and to talk much about what it sees. It is meant to be the eyes and the voice, and to embody the wisdom and will of its constituents."

# Your Superpowers





- Legislator phone calls and emails get returned.
- Legislators can request investigations and reports.
- Legislator questions trigger research, reconsideration, change.
- Oversight can have as much, or more, impact as legislation.



# Routine or Event-Driven Oversight?

Routine: "cop on the beat"	Event-Driven: "firefighter"
Program Outcomes	Scandal
Budgetary	Disaster
Contracts	Chronic Problems
Compliance	Escalating Problems
Deter Malfeasance	Long-term Investigation

While today's scenario is event-driven, over time the oversight in place could become routine.

- 1. Fact-Finding
- 2. Written Product



3. Hearing

# Fact-finding (1 of 3)

Auditors: Flow of info to assist the Legislature (MI)

- Performance
- Fiscal

Ombuds: Independent, impartial investigations into issues related to state agencies and employees (NE)

- Public Counsel
- Corrections



# Fact-finding (2 of 3)

### **Inspector General:**

Purpose: deter/detect/prevent waste, fraud, and abuse (PA)

Sometimes a law enforcement agency

### **Commissions**

Jail Standards Commission (CO)



# Fact-finding (3 of 3)

- 1. Gather publicly available information
- 2. Make doc/witness requests (subpoenas?)
- 3. Review Evidence
- 4. Interviews



# Hearings

- Best tool for raising visibility of an issue and effecting change
- Typically, where you present rather than discover information
- Set goals for hearing and check to see if they're being achieved
- Develop a media plan



### Written Product

- Internal (for committee members and staff) and External (for the public)
- Builds consensus during fact-finding and after inquiry is over
- Reports can be very short (memo, fact sheets)



# Follow-Up

- Consider solutions during fact-finding
- Include specific recommendations in any report
- Get commitments for reform during hearings
- Create plan that assigns tasks to specific members/staff
- Give yourselves a deadline and be transparent about results



### Recommendations for Strengthening Oversight

- Joint oversight committee with balanced party membership
- Bipartisan approach to topics, inquiry, witnesses, questions, etc.
- More follow-up (e.g., hearings) on reports
- Include contract oversight
- Create oversight plan
- Post status and results of investigations on legislature's website

- Entire legislature
- House/Senate
- Caucus
- Committee
- Investigation

### Scenario

• A diabetic inmate at Fox River State Penitentiary died in solitary confinement. The Inspector General, who responds 24/7 to unexpected inmate deaths, was told by the medical staff that they were not informed where he had been moved, so he had not received his insulin or had his blood sugar levels monitored in almost two weeks. He was also sent regular meals, rather than those meant for his special diet, compounding the situation.

What are the next steps for the legislature?

# The Experts Investigate

**Ombuds**: Investigates circumstances of John Doe's death and phone calls from diabetic inmates at the same prison who report concerning issues.

**Legislative Auditor General**: Investigates ongoing issues of lack of communication between medical and prison staff at Fox River State Penitentiary, poor records management, and failure to meet national standards.

**Inspector General**: Visits the rest of the state's prisons to determine if this is a systemic problem or is confined to one prison.
