Our Programs



Empowering High School Teachers and Students

Our civic education program *Learning by Hearings* provides high school lesson plans, classroom videos, and professional development opportunities to teachers free of charge.

Listening to the American People

Our *People-Centered Oversight* program is focusing legislators' attention on who should be at the heart of their fact-finding and oversight work: the American people they serve.

Advocating for Fact-Based Debates in the Public Square

When done well, legislative oversight identifies facts, fosters debate, and builds public consensus. Through panel discussions, commentary, and expert advice to legislatures, we offer insights on how lawmakers can promote the fact-based public discourse and accountable government that underpins our democracy.











Congressional Office

Our Washington, D.C. office is a hub for strengthening the practice of congressional oversight. Through hands-on, bipartisan boot camps, we train staff from both chambers on how to investigate effectively to uncover facts and pave the way for responsive and transparent government. We offer specialized training for committee clerks, monitor emerging case law that shapes Congress's investigative powers, and support the next generation of legal experts through our summer law internship program in congressional oversight committees. Beyond the Hill, we share a broad range of resources with educators, legal scholars, and oversight practitioners working to understand and improve the vital role oversight plays in our democracy.








State Oversight Academy

The Levin Center's State Oversight Academy (SOA) is the nation's first and only institution solely dedicated to strengthening bipartisan, fact-based oversight in state legislatures—an essential pillar of effective government and a healthy democracy. As a national hub for legislators, scholars, and civic leaders, SOA is advancing transparency, accountability, and effectiveness while countering disinformation that fuels division and undermines public trust. Through expert-led training, innovative resources, and a vibrant community of practice, SOA empowers state leaders to conduct meaningful oversight that renews democratic norms and fosters civil discourse. SOA is shaping the future of state government—one informed question at a time.

Learning by Hearings is a free civic education program that brings real-world relevance into high school civics and U.S. history classrooms. 







Research & Scholarship

We offer an annual fellowship for early-career scholars, honor outstanding academic papers through our research award, and are developing first-of-their-kind datasets to support new studies and methodologies. Our expanding library of resources helps scholars explore oversight from every angle. By connecting academics nationwide through our listserv and regular roundtables, we are building a vibrant community of oversight researchers. Congressional Oversight Records Database (CORD)

The Congressional Oversight Records Database (CORD) is a unique resource that brings clarity, context, and accessibility to one of Congress's most important functions: oversight. As the first comprehensive collection of congressional oversight reports beginning with the 106th Congress (1999-2000), CORD organizes decades of investigative work into a searchable, standardized, and publicly available tool.



While it is an invaluable asset for scholars studying accountability and governance, its reach extends far beyond academia—empowering journalists, informing congressional staff, and engaging the public. With CORD, we unlock the potential to understand how Congress has held power to account over the last 25 years and how it can do so more effectively in the future.
